NOTICE TO ALL APPLICANTS/PETITIONERS

To avoid the inconvenience of a summary denial of your application/petition, please be advised of the following:

- 1. All sworn statements/affidavits must be properly notarized, indicating therein the proof of identification of the party being sworn by the notary public.*
- 2. All documents to be submitted must be properly authenticated. Documents executed outside of the Philippines must be authenticated by officials of the Philippine foreign service at its place of execution or nearest to it. Any document executed within the Philippines must be duly certified by the offices having official custody of the originals.*
- 3. All necessary documents required in nos. 1 & 2 must be submitted and must be in order, otherwise the application or petition cannot be processed immediately.*

**CHECKLIST OF REQUIREMENTS FOR INCLUSION-
CEZA INVESTOR'S RESIDENT VISA (CIRV)**

1. Photocopy of Certificate of Registration as a CSEZFP Enterprise
2. Copy of the Articles of Incorporation
3. Proof of inward remittance of at least US\$150,000.00
4. Proof that the investment of US\$150,000.00 still subsists, either in the form of cash, near cash, or property
5. Duly accomplished CIO Form No. 001 (*attached*)
6. Certificate under oath from a duly authorized physician that the applicant is not suffering or is not affected with any loathsome, dangerous and contagious disease
7. Certificate from any competent mental institution that the applicant has not been institutionalized for any mental health disorder or disability; if secured in applicant's country or place of residence, it must be duly authenticated by the Philippine Embassy or Consulate in or closest to the applicant's country
8. NICA Clearance
9. Copy of Passport
10. NBI Clearance
11. BID Clearance

For inclusion of investor's spouse and/or minor children

In addition to nos. 1 to 11, the following must be submitted:

1. **For the spouse**, certified true copy of marriage contract duly authenticated by the Philippine Embassy or Consulate in or closest to applicant's country
2. **For their minor children**, certified true copy of their birth certificates or any instrument showing proof of affiliation authenticated by the Philippine Embassy or Consulate in or closest to applicant's country
